**SALES COMPETITION PARTICIPANTS:** Sales Representatives from any participating Dealer responsible for the sale of ECOMAX 404 & 504 in New South Wales

**SALES COMPETITION PERIOD:** 1st of May to 31st of August 2024 (all sales must be uploaded into the system by 31st of August 2024 11:59pm).

**INSTRUCTIONS:** The instructions on how to participate form part of the Terms & Conditions and by completing the form it is deemed as acceptance of the Terms & Conditions. The Participant must comply with these Terms & Condition to be valid.

## THE PROMOTION:

The WIN BIG WITH 404 & 504! is a Sales Competition targeting Sales Representatives from participating dealers in NSW.
